Refunds, Missed/Make-up class policy: There are no refunds for missed classes for any reason. Make up classes are solely the benefit of Membership, which is available to students for a one-time fee of \$100. Membership also entitles members to a discount for private lessons, classes, free events and other benefits as more fully described on the website. Najia has an obligation to treat all students equally and requests that students do not ask her for preferential treatment. A great deal of work and expenses go into making these classes possible for everyone. The Class Series allows you to take classes during a specified period at a select location, rather than entitlement to a specific number of classes.

ASSUMPTION OF THE RISK and RELEASE OF LIABILITY: I, the undersigned (Class or Workshop Participant), hereby acknowledge that there are certain risks of physical injury attendant in taking dance classes and workshops, and I knowingly assume these risks. I hereby irrevocably & unconditionally release & hold harmless from liability Najia of Philadelphia Bellydance, Sangha Space, Lori Coyle, and Judith Huczko, her trustees, agents, heirs, and assigns (hereinafter collectively referred to herein as .Najia') from any and all claims, demands, actions, and judgments of whatever kind or nature which I, my heirs, executors, administrators, and/or assigns may have against Najia which occur during, are caused by, or are related to, or arising out of the above Class, Classes, or Workshop. I understand that this Release from Liability irrevocably & unconditionally releases & holds Najia harmless from any financial liability for any injury, bodily harm, sickness, illness, or loss of life that I may suffer, and/or from any economic harm or loss of property occurring during, caused by, relating to, or arising in any way out of the above Workshop, Class, or Class Series. I further agree to indemnify Najia for any and all claims brought by me or anyone on my behalf related to my taking this class or workshop, including attorneys fees and costs.

NON- COMPETE and NON-SOLICITATION AGREEMENT: I hereby agree not to compete with Najia and I will not set up a dance studio or teach belly dancing within a ten (10) mile radius of Delaware County, Pennsylvania for a period of two (2) years unless I obtain Najia's written consent. I acknowledge and agree that Najia has spent decades studying the art of belly dance and has developed unique teaching techniques and styles which are her proprietary property. I also agree not to solicit or contact Najia's active customers and clients for the purpose of teaching them belly dance, and I agree that these restrictions on soliciting Najia's current customers or competing with Najia for the stated time period and geographic distance are reasonable, and I agree that if Najia incurs any legal fees and costs in enforcing these reasonable restrictions against me that I will reimburse Najia for all said legal fees and costs.

I understand that Najia takes photographs and videos of her students and participants in her dance classes, workshops, retreats, potlucks, Red Tent Goddess Nights, and other projects and that I may be in some of these photos and videos; I hereby give my permission for Najia to use photographs and videos of me in her publications, advertisements, social media, and other promotional materials.

I, the undersigned, have read the policy on no refunds and make up classes, the Assumption of Risk and Release from Liability, Non-Compete and Non-Solicitation Agreement, and I understand these policies and terms and agree to them. I am executing this Registration Agreement voluntarily, with full knowledge of the significance of the terms herein, and I intend to be legally bound by the terms of this Agreement.
